Low-moderate income filers can get the assistance they need to file their federal and state taxes – for free.

software. It usually takes about an hour and support from IRS-certified VITA support specialists is available via email, chat, or phone. Secure software guides you through the process to ensure you get your maximum refund.

- Have My Taxes Prepared for Me is available to filers making about \$67,000 or less who are not comfortable preparing their own taxes. Returns can be prepared online or in person, and take 1-2+ weeks to be processed.
